Notes to physician

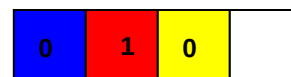

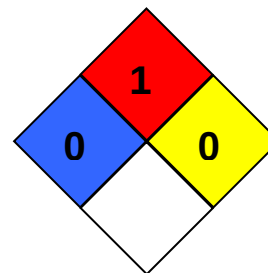
