Potential health effects

Primary routes of exposure

Routes of entry for solids and liquids include eye and skin contact, ingestion and inhalation. Routes of entry for gases include inhalation and eye contact. Skin contact may be a route of entry for liquified gases.

Acute toxicity:

Contact with molten product may cause thermal burns. The resin in pelleted form poses a low hazard.

Irritation:

Corrosive to the skin, eyes and respiratory system. Irritation is possible when the product comes in contact with the skin, respiratory tract or the eyes.

Repeated dose toxicity:

No adverse effects have been reported in the processing and use of the product. No known chronic effects.

Information on: Caprolactam

Animal studies indicate that caprolactam may affect the liver and kidneys.

4. First-aid measures

General advice:
