

Product description

Ultramid® AR 133/GF Black is a polyamide 66, reinforced with 33% of glass fiber, heat stabilized, for injection moulding. It contains recycled raw materials. This grade offers a good combination between thermal and mechanical properties. This product is not suitable for hot runners.

The data provided in this document are based on mean values of a significant number of measurements. However as this products contains recycled materials, its properties may vary over a larger range than a material made from virgin raw materials.

Injection Notes

The material is supplied in airtight bags, ready for use. In case that the virgin material has absorbed moisture, it must be dried with a dehumidified air drying equipment, dew point mini -20°C. Recommended time 2-4h

Injection Advice:

- For reinforced polyamides, BASF SE recommends the use of steel with a high content of carbon, and purified for polishing, to avoid or limit the abrasion. For example: X38CrMoV5-1 (EN Norm) - 1.2367 /1.2343 (DIN Norm) or X160CrMoV12 (EN Norm) - 1.2601 /1.2379 (DIN Norm). In the case of high requirements on surface quality a mould temperature of up to 120°C can be considered.
- The processing parameters like processing temperatures are a recommendation and can be adjusted in function of injection machine size, part geometry / design.
