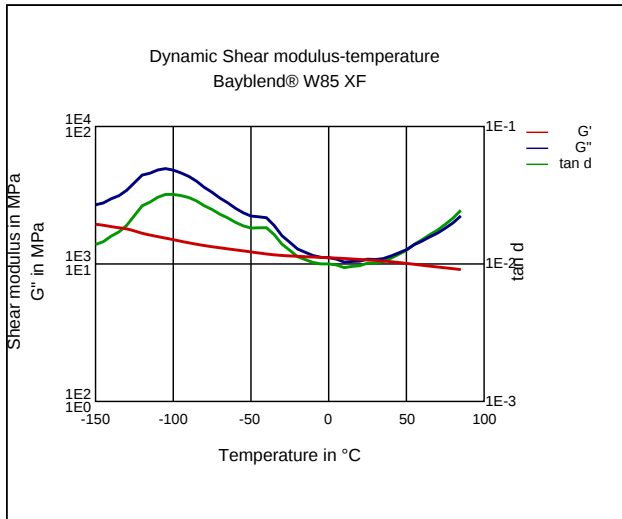

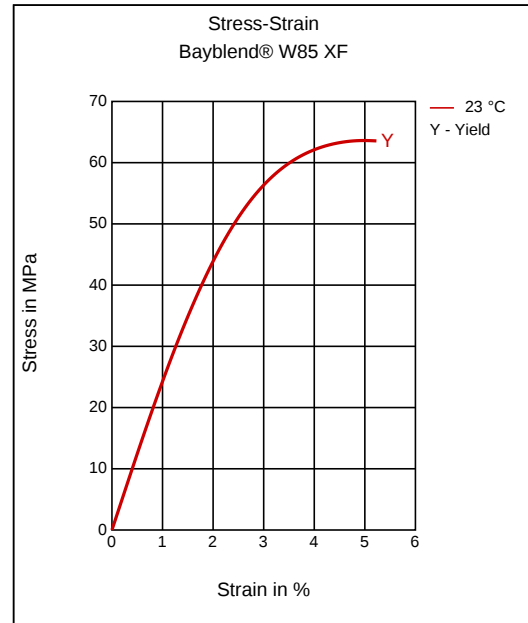

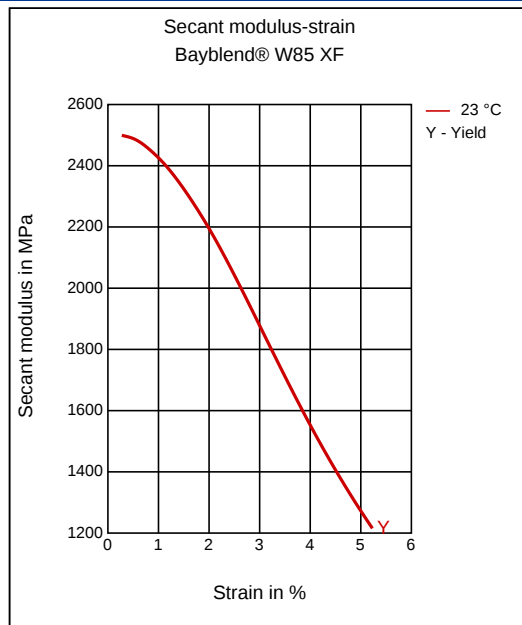
Dynamic Shear modulus-temperature
