1. PACKAGING

The product is supplied in Bulk bag with a net weight 800kg.

The inside film is formed by co-extruded film with polyethylene and nylon that prevents the leakage of the blowing agent and absorption of moisture outside and build up static electricity.

2. TRANSPORTATION

The product is classified as dangerous material to transport to the UN2211. It must be always protected from the effects of weather. So container type is open top

3. STORAGE

The product must be to store in original sealed bulk bag, a well ventilated room below 20°C. The product from partially emptied or damaged packages must be processed immediately.

4. HEALTH, RISK OF FIRE

During work with EPS, all have to read MSDS carefully.

EPS are flammable materials. It can only be handled in well ventilated areas with sufficient relative humidity(>50%), where all the metal part are grounded. Smoking, welding, drilling, grinding and using naked flame is prohibited in areas where EPS is handled.
